PROFESSOR ANAND MENON

Expert on the EU and Brexit



Anand Menon is Professor of European Politics and Foreign Affairs at Kings College London and Director of the ESRC-funded UK in a Changing Europe initiative. He has written widely on many aspects of EU politics and policy and on UK–EU relations. He is a frequent contributor to the media on matters concerning the UK's relations with the EU.

DR ANGUS ARMSTRONG

Expert on trade



Dr Angus Armstrong is Director of the Rebuilding Macroeconomics Network at the National Institute of Economic and Social Research. Formerly a Managing Director at Deutsche Bank and Head of Macroeconomic Analysis at HM Treasury, he is an honorary professor at Stirling University and visiting professor at Imperial College London.

PROFESSOR DAVID PATON

Expert on trade



David Paton is Professor of Industrial Economics at the University of Nottingham. Beyond Brexit, his research interests include the economics of gambling, teenage pregnancy and cricket. He has acted as an adviser to several government departments, including HM Revenue and Customs, the Department of Culture, Media and Sport, and the Department of Trade and Industry.

DR THOMAS SAMPSON

Expert on trade



Dr Thomas Sampson is Assistant Professor of Economics at the London School of Economics and Political Science. His research interests relate to international trade, growth and development. He has also previously worked for the World Bank and in international development.

SHANKER SINGHAM

Expert on trade



Shanker Singham, a trade and competition lawyer, is director of economic policy and prosperity studies at the Legatum Institute, and chairman of the Institute's Special Trade Commission. He has written the leading textbook on competition and regulatory systems, led the market access practices of two law firms, and represented multinational companies and governments.

PROFESSOR CATHERINE BARNARD

Expert on trade and immigration



Catherine Barnard is Professor of European Union law at the University of Cambridge. Her research interests lie in labour rights in the EU, the free movement of workers, the self-employed and service providers in the EU, as well as EU citizens, and the issue of 'posted' workers.

PROFESSOR DAVID COLEMAN

Expert on immigration



David Coleman is Emeritus Professor of Demography at the University of Oxford. His research interests include comparative demographic trends in the industrial world, the future of fertility, the demographic consequences of migration and the demography of ethnic minorities. He is a former Special Adviser to the Home Office and the Department of the Environment.

PROFESSOR JONATHAN PORTES

Expert on immigration



Jonathan Portes is Professor of Economics and Public Policy at King's College London. He was previously a civil servant and was Chief Economist at the Cabinet Office in the aftermath of the 2008 financial crisis. His current research concentrates on immigration and labour mobility in the EU and beyond and on the economic implications of Brexit.
